

1 and, I guess, the probative value is highly outweighed by the
2 prejudicial nature of that sort of testimony.

3 THE COURT: Mr. Smith?

4 MR. SMITH: Can I see that deposition? If it please
5 the Court. Further on down in that testimony right after
6 where Mr. Redman questioned:

7 "Q. Did you know what was going to happen prior to this
8 happening?"

9 A. I was -- I heard -- I overheard them talking about rape
10 if the person gave them a hassel."

11 But no means were ever mentioned. "I wasn't putting two
12 and two together on what was going down." In other words,
13 she does have knowledge and she told Mr. Redman that. She
14 had knowledge and would corroborate what Mr. Dean has
15 indicated on direct and cross-examination. I think it's
16 definitely relevant and corroborates and it shows they
17 planned -- Well, she wasn't real clear on that. She did
18 indicate she overheard the situation. And I think that that
19 corroborates with what Mr. Dean has testified to.

20 MR. REDMAN: My problem is the vagueness that she
21 overheard it. That's -- It's pretty weak and again I would
22 say that the probative value of that certainly is outweighed
23 by the prejudicial nature.

24 THE COURT: There's evidence in the record that
25 demands for money were made early on after the people entered
the apartment. There is evidence of prior conversations
involving the defendant with respect to such activities. And
I can't say within the context of the motion in limine that it

1 would be improper to bring it up. I'm going to have to hear
2 what it is. If there's proper foundation, if it reflects
3 testimony of the defendant and so on, I'll let it in. I
4 don't believe in the circumstances, Mr. Redman, that I can
5 grant that motion. It is overruled.

6 MR. REDMAN: I have a couple more motions in limine.
7 JoAnn Taylor -- Well, again, I would move in limine that the
8 State not elicit any testimony from JoAnn Taylor wherein
9 she recalls a conversation with Joseph White and he said that
10 he was talking about a killing in North Carolina and a
11 reference to the Mafia. Maybe you're not even going to get
12 into that.

13 MR. SMITH: I wasn't.

14 MR. REDMAN: Well, I think it's so far removed.

15 THE COURT: You've paraphrased the situation. I
16 think anything about the time frame or what was specifically
17 said, whether it is something that he indicated he partici-
18 pated in or what, you'd have to be more specific for me.

19 MR. REDMAN: It had to do with -- and Judge I don't
20 have it her with me -- it had to do with one of her first
21 statements to the police. They asked about Joe White and
22 what she knew about him. "Well, he told me that he'd been
23 involved in a killing in North Carolina and that he was
24 somehow Mafia-related.

25 MR. SMITH: I think words came up and I think this
is how defense counsel would continually ask what she knew
about him and this is how it came out. I don't plan on
asking about that type of situation, but I'm not so sure with

1 with the nature whether it's proper evidence on the
2 character of the defendant either. If they ask the question--

3 THE COURT: Well, the general rule on prior
4 offenses is if it shows intent, motive, any of those things --
5 Again, it's going to depend a little bit on how it comes
6 up. If the State doesn't ask it, it's one thing. If it
7 comes out on cross, I don't know I can say that that would
8 be inappropriate, not inappropriate but not admissible.

9 MR. REDMAN: I'm just saying I would not like the
10 State to bring that up.

11 THE COURT: Well, Mr. Smith, you'll have to respond
12 to that.

13 MR. SMITH: Your Honor, we are not planning and have
14 not discussed at all, and we are not planning that to be
15 a question regarding "Tell us about Joe White" type of
16 situation.

17 THE COURT: I think what I'm going to do is to take
18 that under advisement because I don't know in what context.
19 If it appears that it's coming and you want to approach the
20 bench on it, let's deal with that at that stage. I am
21 reluctant to move.

22 MR. REDMAN: I understand. More than anything
23 I want to alert you on the possibility. I have one final
24 motion in limine in regards to Lisa Podendorf or Lisa Brown.
25 I'd move in limine that the State not be allowed to elicit
any testimony from her that she recalled the defendant would
say when he was drunk that he would just like to go out and
kill someone.

1 THE COURT: Mr. Smith?

2 MR. SMITH: Again, Your Honor, as the previous
3 motion, we weren't intending to ask anything in that area.
4 I think that again was elicited by defense, "What did he do
5 when he was drinking?" We're not even indicating he was
6 drinking that night. You know if it comes out in cross, it's
7 appropriate, an appropriate response. I don't think it's
8 inappropriate.

9 MR. REDMAN: Again, I'm just asking the State
10 not to bring it up.

11 THE COURT: I'm going to take that one under
12 advisement also. Some of these things in a a given context,
13 I think would be admissible, but I'm going to have to hear.
14 I can't -- I don't feel I can make a judgment on that at
15 this time. So I'll take that one under advisement.

16 MR. REDMAN: As long as we're alerted before the
17 question.

18 THE COURT: Well, if you see it coming, you can
19 certainly approach the bench. We'll just take it from there.

20 ** ** ** **

21 (At 9 a.m. on November 7, 1989 with counsel for the
22 parties present and the defendant present and the jury IN the
23 jury box, the following proceedings were had:)

24 THE COURT: Good morning ladies and gentlemen.
25 All right. Gentlemen, are we all ready to proceed this
morning?

MR. SMITH: Yes, Your Honor. The State would call
JoAnn Taylor to the stand.

1 JOANN TAYLOR

2 Called as a witness on behalf of the
3 plaintiff, having been first duly sworn,
4 testified as follows:

4 DIRECT EXAMINATION

5 BY MR. SMITH:

6 Q. Would you state your name for the record, please?

7 A. It's Ada JoAnn Taylor.

AGREEMENT:

1. The defendant has agreed to waive her preliminary hearing rights in this action.
2. The State has agreed to file an amended Information charging the defendant with Second Degree Murder of Helen L. Wilson, and defendant will plead guilty to said amended Information.
3. The defendant has agreed, if necessary, to waive her preliminary hearing rights on this amended Information, to waive her 24-hour notice and service of the amended Information.
4. The defendant agrees to testify truthfully to the best of her recollection in any and all cases and give total cooperation to the State of Nebraska regarding the homicide of Helen L. Wilson.
5. The defendant and the State will stipulate and agree that the defendant should not be sentenced in this matter until all homicide cases have been tried in the Helen L. Wilson matter.
6. The State will make a recommendation of 15 years imprisonment for a sentence in this cause if the defendant complies with all of the above.

24 Debby was. Who went in the apartment?

25 A Myself, Debra Shelden, James Dean, Thomas Winslow, and
Mr. White.

Q Where was Mr. White?

A He was having words with Mrs. Wilson.

1 Q. What was he saying?

2 A. He was demanding money, that she knew why or she knew
3 why he was there. Excuse me.

4 Q. What was she saying?

5 A. To leave her alone and go away.

6 Q. Did he make any response to that when she said that?

7 A. He slapped her.

8 Q. Where was Mr. Winslow?

9 A. Standing not too far from Mr. White.

10 Q. In relationship to Mrs. Wilson, where was Mr. Winslow?

11 A. A little bit farther than Mr. White was to her.

12 Q. Where was Mr. Dean?

13 A. Kind of closer to Debby, and I -- he was just kind of
14 standing in between the kitchen or excuse me, the living
15 room and the doorway.

16 Q. What happened next?

17 A. They continued to argue, and Mr. White took her by her
18 arms and him and Mr. Winslow took her toward the bedroom, and
19 I followed.

20 Q. What happened next?

21 A. They -- Mr. White and her continued to argue. They got
22 her down on the floor in the bedroom.

23 Q. What was the argument about?

24 A. Money.

6 THE COURT: You may.

7 Q. (By Mr. Smith) Handing you Exhibit No. 13. Can you
8 tell me what that is, if you know?

9 A. Yes. It's a picture of the bedroom.

10 Q. Which bedroom?

11 A. Mrs. Wilson's bedroom.

12 Q. What happened after she was on the floor?

13 A. They were arguing with her and Ms. Gonzalez had come in
14 while the guys were -- had Mrs. Wilson on the floor, and
15 Ms. Gonzalez got kicked in the nose.

16 Q. What happened after Ms. Gonzalez got kicked in the nose?

17 A. She went out of the room and Debby Shelden came in and
18 tried to help Mrs. Wilson, trying to get the guys to leave
19 her alone.

20 Q. What happened then?

21 A. Debra got elbowed backwards.

3 Mrs. Wilson up off the floor in the bedroom and took her
4 towards the living room, and I followed them back out.

5 Q. Where was James Dean?

6 A. In the living room at this time.

7 Q. Where was Kathy Gonzalez?

8 A. She was nowhere to be seen. I believe she was in the
9 bathroom though, because I could still hear her voice.

10 Q. Where was Debra Shelden?

11 A. Well, this time she was in the bedroom, kind of
12 knocked -- I don't remember if she was knocked out, but I know
13 she was woozy.

14 Q. Did she ever get up again?

15 A. Yes, sir.

16 Q. How long did it take to the best of your knowledge?

17 A. 15, 20 minutes.

12 Q. In relationship to that couch that you previously
13 testified to?

14 A. Yes, sir.

15 Q. Where was her head?

16 A. Closest to the couch.

17 Q. Where were her feet?

18 A. Going back towards the other room.

19 Q. Which other room?

20 A. Well, she would be laying where her feet were pointing
21 towards the bedroom and the kitchen area.

22 Q. You've indicated, I believe, that they got her to the
23 floor. How did they do that?

24 A. I'm not sure if they pushed her down or if she tripped.

25 Q. What happened next?

A. They had her hands behind her, underneath her and

Mr. White had his hand up on her chest or up in this area,

and he was undoing his trousers with his other hand.

1 MR. SMITH: Let the record reflect the witness
2 put her right hand up on the upper part of the center part
3 of her chest.

4 THE COURT: All right. The record will so reflect.

5 Q (By Mr. Smith) You've indicated he had one hand in
6 that location; is that correct?

7 A Yes, sir.

8 Q What was he doing with the other hand?

9 A Undoing his belt and his pants.

10 Q What was Mrs. Wilson doing?

11 A Struggling, arguing.

12 Q Where were you?

13 A By her head.

14 Q What were you doing?

15 A Standing there.

16 Q Was there anything near you at that time?

17 A There was a smaller green footstool at the time.

18 MR. SMITH: May I approach the exhibits, Your Honor?

19 THE COURT: Yes.

20 Q (By Mr. Smith) Handing you Exhibit No. 2. Can you tell
21 me what that is, if you know?

22 A It's a picture of Mrs. Wilson's body.

23 Q You've indicated there was a small green footstool. Is
24 that in that exhibit?

25 A Yes, sir.

Q Is that the footstool as you remember it?

A Yes, sir.

Q I see it's upside down; is that correct?

A. Yes, sir.

Q Do you know how it got there?

A. I shifted my foot and kicked it over.

Q What happened after Mr. White unbuckled his belt?

A. Mr. Winslow was holding onto Mrs. Wilson's legs.

Q How was he holding onto her legs?

A. He spread them.

Q Then what happened?

A. Mr. White raped her.

Q Did you see him rape her?

A. Yes, sir.

Q Was he saying anything when he was raping her?

A. That she deserved it and that she was tight.

Q What were you doing?

A. I had placed a pillow over her face, because I didn't want her to see the face that would haunt her.

Q Why would the face haunt her?

A. I know from previous experience that when you're raped, the face can haunt you.

Q What happened next?

A. When Mr. White got finished, him and Mr. Winslow switched places.

Q What was Mr. White doing then?

A. After he pulled his trousers back up and redone his belt and everything, he was holding Mrs. Wilson's legs.

Q What did Mr. Winslow do?

A. He raped Mrs. Wilson also, but he had anal intercourse with her.

1 Q Where was Mr. Dean during this time?

2 A Standing pretty much where he was earlier back over by
3 the vicinity of the bedroom and kitchen doorway area.

4 Q What was Mrs. Wilson doing when they switched places?

5 A Struggling.

6 Q What were you doing?

7 A Still -- I still had the pillow over her face.

8 Q Do you know how hard you were placing that pillow over
9 her face?

10 A I beleive I had no pressure on the pillow to my
11 knowledge.

12 Q Could you have had pressure on the pillow?

13 A Yes, sir.

14 Q After Mr. Winslow was done, what happened next?

15 A I was tossed a pink towel, because I had -- I was -- I
16 removed the pillow.

17 Q Was Mrs. Wilson moving anymore?

18 A No, sir.

19 MR. SMITH: May I approach the exhibits?

20 Q (By Mr. Smith) Handing you, again, Exhibit No. 2, Do
21 you see the pink towel that you were handed in that exhibit?

22 A Yes, sir.

23 Q Where?

24 A It's laying across the scarf that's on her face.

25 Q After Mrs. Wilson wasn't moving anymore, what happened
next?

A We all started looking around the apartment for money.

Q Where did you look?

1 A. The bedroom.

2 MR. SMITH: May I approach the exhibits, Your Honor?

3 THE COURT: Yes.

4 Q. (By Mr. Smith) Handing you what is Exhibit No. 12.
5 Can you tell me what that is?

6 A. Yes, sir. It's a picture of the dresser, one of the
7 dressers in the bedroom.

8 Q. Tell the jury what you did in that bedroom when you
9 were looking?

10 A. I walked around and mainly looked around for money.
11 There was money laying on top of her dresser. I picked that
12 one \$20 bill off the dresser and placed it in my pocket.

13 MR. SMITH: May I approach the exhibits, Your
14 Honor?

15 THE COURT: Yes.

16 Q. (By Mr. Smith) Handing you Exhibit No. 17. Can you
17 tell me what that is, if you know?

18 A. Yes, sir. That's part of the kitchen area.

19 Q. Did you go in that area?

20 A. Yes, sir.

21 Q. Why?

22 A. After -- Well, while everyone else was looking for
23 money after I found the 20 --

24 Q. Handing you Exhibit No. 16. Can you tell me what that
25 is, if you know?

A. Yes, sir. That's the other part of the kitchen where
the coffeepot and everything is.

Q. Is that where you made coffee?

1 A. Yes, sir.

2 Q. Who drank the coffee?

3 A. I believe Mr. White and Mr. Winslow.

4 Q. Did you?

5 A. No, sir.

6 Q. Why did you make it?

7 A. I don't know to be totally honest with you.

8 Q. What happened after you found the \$20 bill.

9 A. I said, "I had it. Let's go."

10 Q. Then what happened?

11 A. The guys continued to look around.

12 Q. Did you go into the kitchen area after that?

13 A. No, sir.

14 Q. Did you look into the kitchen area after that?

15 A. No, sir.

16 Q. What happened next?

17 A. Somebody had said something about Ms. Gonzalez's nose.

18 So I told her to put ice on it.

19 Q. What happened next?

20 A. We were -- The guys were still looking around for money,

21 because Mr. Dean was naming places to look.

22 Q. Was any other money found?

23 A. Not to my knowledge.

24 Q. Ms. Taylor, you have indicated from Exhibit No. 2 that

25 there was a pink towel given to you; is that correct?

A. It was tossed to me, yes, sir.

Q. Who tossed it to you?

A. Mr. White. He said I knew what to do with it.

1 Q. Why would you know what to do with it?

2 MR. REDMAN: Your Honor, at this point I'm going
3 to object. It's speculation plus it gets into an area that
4 we've discussed in camera.

5 THE COURT: Counsel approach the bench.

6 (At this point, counsel for the
7 parties approached the bench and
8 an off-the-record discussion was
9 had, in low tones, between Court
10 and counsel.)

11 THE COURT: We're going to take a recess at this
12 time, ladies and gentlemen.

13 (Whereupon, a recess was taken
14 from 10 to 10:18 a.m.)

15 (At 10:00 a.m. with counsel for the parties present
16 and the defendant and jury NOT present, the following
17 proceedings were had in chambers.)

18 THE COURT: Let the record reflect we are proceed-
19 ing in chambers out of the presence of the jury. At the
20 conclusion of the testimony in open court, the witness test-
21 ified she was tossed a towel and that the defendant said she
22 knew what to do with it, and it was then asked by the State to
23 the effect why that was. The Court indicates that at this
24 point a hearing outside of the presence of the jury is
25 necessary to determine what this evidence may be and if it is
admissible. What showing would you like to make, Mr. Smith?

MR. SMITH: If it please the Court: We would
advise the Court we believe the witness has told the State
that prior to coming to Beatrice with the defendant, she had
an apartment and the defendant was allowed to be there.

1 THE COURT: Where?

2 MR. SMITH: In California. She one day came home
3 not knowing anyone was there, walked in and found the
4 defendant having sexual intercourse with a young lady at
5 that time. The young lady's head was covered with a pillow
6 case. The witness would say she left, returned later, had
7 a conversation with the defendant regarding that, and she
8 indicated to the defendant that she felt the female was a
9 little wierd doing that, and the defendant said to her, "No,
10 that's what I wanted her to do." It was at his insistance
11 that the individual have something over her head.

12 MR. REDMAN: The problem with that is that what
13 we're talking about now is not the same as, apparently, what
14 JoAnn supposedly witnessed in California. The pillow case
15 was over her head during the act of intercourse and this is,
16 obviously after the act of intercourse is complete, in fact,
17 after the defendant, apparently, is dead, from what she's
18 testified. The victim was dead. So they are not similar and
19 I don't know that a towel over the head is the same as a
20 pillow case over the head. And I think it's still speculation
21 on a lot of this on JoAnn's part anyway, and I don't know
22 when this California thing happened. I don't know how remote
23 it is.

24 THE COURT: Well, we have testimony she's only known
25 him six or eight months, and I think that's in the record.

26 MR. REDMAN: It seems to me, again, that the
27 prejudicial value highly outweighs the probative value of
28 this.

1 THE COURT: Mr. Smith, any response you want to
2 make?

3 MR. SMITH: No, Your Honor.

4 THE COURT: Well, the rule appears to be as
5 announced in the case State vs. Koka, 216 Neb. 76 that
6 evidence of other crimes is admissible where there are
7 unique element signature similarities between them and the
8 offense charged where the evidence is otherwise so related
9 in time and place and circumstance. As to have a substantial
10 probative value in determining the guilt of the accused, I'm
11 not sure that the rule is limited to other crimes. The
12 statute speaks of crimes or other acts but nonetheless, the
13 question is whether or not the proffered evidence has a
14 signature-like similarity. The Court has a problem with the
15 fact that what is taking place here is after any alleged
16 intercourse by the defendant and some evidence to indicate
17 that at this point Mrs. Wilson was dead. If there is some
18 relevancy, if the prejudice outweighs it, it ought not be
19 received.

20 I have considerable difficulty, Mr. Smith, in finding a
21 signature-like quality to this given the sequence of events,
22 because this didn't happen during any act of alleged inter-
23 course but comes afterwards and, apparently, the time when
24 the victim was dead. At least the possibility is there but
25 even if that were true, the other of it causes me concern.
~~I think that the discretion of the Court in this case has got~~
to be exercised in the defendant's favor. I don't believe
the circumstance is sufficiently similar to come within

1 the signature similarity rule. Therefore, I'm going to treat
2 what you have said as an offer of proof that the defendants
3 have observed thereto. Objection is sustained. I think it
4 could be reversible error to permit this testimony in these
5 circumstances.

6 (At 10:18 a.m. with counsel for the parties present
7 and the defendant present and the jury IN the jury box, the
8 following proceedings were had:)

9 THE COURT: Will you have Ms. Taylor brought back
10 in the courtroom.

11 JOANN TAYLOR RESUMED THE WITNESS STAND AND TESTIFIED
12 FURTHER AS FOLLOWS:

13 (DIRECT EXAMINATION
14 BY MR. SMITH:)

15 Q Handing you what's been marked or is Exhibit No. 18.
16 Can you tell me what that is, Ms. Taylor?

17 A Yes, sir. It's a photograph of the part of the kitchen
18 area.

19 Q All right. What is in that photograph?

20 A The doorway mainly and you got your kitchen chairs and
21 everything.

22 Q All right. Handing you Exhibit No. 19. Excuse me.
23 Have you seen that before?

24 A Yes, sir.

25 Q When was that?

A When I was in Mrs. Wilson's apartment.

Q In the sequence of events, when did you see that?

A Before -- Well, when I went into make coffee later on.

Q Later on. When later on?

1 A. When we were leaving.

2 Q. Handing you what is Exhibit No. 19. Can you tell me
3 what that is, if you know?

4 A. Yes, sir. It's a part of the \$5 bill.

5 Q. Have you ever seen that before?

6 A. Yes, sir.

7 Q. Where?

8 A. Not in Mrs. Wilson's apartment, but I've seen it done
9 before.

10 Q. All right. You've indicated you saw that done before.
11 Saw what done before?

12 A. A \$5 bill being torn.

13 Q. After you'd found the \$20 bill, you indicated you said
14 it was time to leave?

15 A. Uh-huh.

16 Q. What did you do then?

17 A. I was ready to leave.

18 Q. What happened next?

19 A. Well, we waited around for the guys to decide they were
20 ready to go.

21 Q. How long was that?

22 A. Well, not long.

23 Q. Do you know who left first?

24 A. Yes, sir.

25 Q. Who?

26 A. ~~It was myself, Debra Shelden and James Dean.~~

27 Q. Where did you go?

28 A. We were going back out to the car.

1 Q Did you go back out to the car?

2 A We started to. We got out in the hallway, and we got
3 as far as the staircase, and the lights went out on it.

4 Q All right. Then what happened?

5 A Well, we -- After Jim -- I tripped and Jim Dean caught
6 me before I fell. We made our way to the back door before
7 the lights came back on.

7 Q What happened next?

8 A We went on out to the car.

9 Q All right. So who's in the car then?

10 A Myself, Debra Sheldon, and James Dean.

11 Q Did anyone else come to the car?

12 A Yes, sir.

13 Q Who?

14 A Mr. White and Mr. Winslow.

15 Q In which order, if you remember?

16 A They came pretty much right together.

17 Q How long did you wait in the car before they came?

18 A Approximately 15 to 20 minutes.

19 Q Was there any conversation in the car, then, yes or no?

20 A Yes, sir.

21 Q Who was talking?

22 A Myself and Mr. White.

23 Q What were you talking about?

24 A I asked what he ripped.

25 Q Where did you hear a rip?

A In the apartment.

Q When?

1 A. Shortly before we left.

2 Q. Did Mr. White respond to you?

3 A. Yes, sir.

4 Q. What did he say?

5 A. He said just his five.

6 Q. Did you ask him any more questions?

7 A. No, sir.

8 Q. Did he make any more comments about that?

9 A. No, sir.

10 Q. Did you know what he was talking about when he said just
his five?

11 A. Yes, sir.

12 Q. Why would that be?

13 A. He --

14 MR. REDMAN: Judge, I'm going to object at this
point in time on the basis I don't know what it's going to
15 be. If it's going to be hearsay or --

16 THE COURT: Conversation with the defendant can't
17 be hearsay. Overruled.

18 Q. (By Mr. Smith) All right. What did you understand it
19 to be?

20 A. He has a trick -- Well, most people call it a trick that
he does with a \$5 bill which is where he rips a \$5 bill.

21 Q. Can you explain to the jury what the trick is?

22 A. I've never really understood it. I know he pulls a

23 \$5 bill out and he does something with it and he ends up with
24 a ripped \$5 bill. And he usually tosses part of it away.

25 Q. What does he do with the other part?

1 A. He usually hangs on to it.

2 Q. When was this conversation in the car?

3 A. Shortly after -- Well, when he and Mr. Winslow came to
4 to the car.

5 Q. All right. What happened next?

6 A. We left.

7 Q. Where did you go?

8 A. Well, we went back the opposite direction, in the alley
9 that we'd come into, and we took a left-hand turn and we
10 dropped Debby off. I believe it was at her mother's or her
11 step-mother's.

12 Q. Why did you drop Debby off?

13 A. She asked to be drooped off.

14 Q. Then who's in the car then?

15 A. There's myself, James Dean, Mr. White, and Mr. Winslow.

16 Q. And what happened next?

17 A. We went out to Marshall's Truck Stop.

18 Q. What did you do there?

19 A. We had breakfast.

20 Q. Do you remember who paid for breakfast?

21 A. Mr. White did.

22 Q. Do you know where he got the money?

23 MR. REDMAN: I'm going to object at this point in
24 time. Improper foundation.

25 THE COURT: Calls for a yes or no answer. I'll
26 permit that.

27 Q. (By Mr. Smith) Do you know where he got the money?

28 A. No, sir.

JoAnn Taylor - Direct

1 Q Do you know whether or not he had any money when you
2 went to the apartment?

3 A Yes, sir.

4 Q And did he?

5 A No, sir.

6 MR. REDMAN: Judge, again, I'm going to object on
7 the basis of foundation.

8 THE COURT: I'll sustain that. You'll have to
9 lay foundation.

10 Q (By Mr. Smith) How do you know?

11 MR. REDMAN: I'll object. He's testifying to facts
12 that are not in evidence. It's never been said he didn't
13 have money.

14 THE COURT: Well, the answer's in.

15 MR. REDMAN: All right.

16 MR. SMITH: Do you want me to proceed, Judge?

17 THE COURT: Yes.

18 Q (By Mr. Smith) Do you know an individual by the name
19 Lisa Podendorf-Brown?

20 A Yes, sir.

21 Q And how do you know that individual?

22 A I used to hang with her and another girl.

23 Q And when was that?

24 A Back in '83 and '84.

25 Q Did you ever see her after the Helen Wilson homicide in
February of '85?

A Yes, sir.

Q Where did you see her?

1 A. In Charles Park.

2 Q. When?

3 A. I believe it was the -- after -- Well, early hours of
4 the 6th.

5 Q. So that would have been the morning after; is that
6 correct?

7 A. Yes, sir.

8 Q. And Charles Park -- Where is Charles Park?

9 A. It's the park right next door to the Beatrice Library.

10 Q. Why did you go there?

11 A. I used to be a library volunteer.

12 Q. And you saw this Lisa Podendorf-Brown there?

13 A. Yes, sir.

14 Q. Did you and she engage in conversation?

15 A. Yes, sir.

16 Q. What was the topic of the conversation?

17 A. Why all the cops were hanging around.

18 Q. Could --

19 MR. SMITH: May I approach the exhibits, Your Honor?

20 THE COURT: You may.

21 Q. (By Mr. Smith) Handing you Exhibit No. 6. Can you tell
22 me what that is, if you know?

23 A. Yes, sir. It's the apartment building in which
24 Mrs. Wilson lived. It's also the view of it you have from
25 Charles Park.

Q. And that is the apartment building that Mrs. Wilson was
killed in on February 5, 1985?

A. Yes, sir.

1 Q So you had a conversation regarding what again?

2 A Why all the cops were out so heavy and what was going
3 on.

4 Q Did you tell her why you thought they were there?

5 A Yes, sir.

6 Q What did you tell her?

7 A MR. REDMAN: I'm going to object on the basis of
8 relevancy and hearsay.

9 THE COURT: Sustained.

10 MR. SMITH: May we make an offer of proof?

11 THE COURT: Let the record reflect that we are
12 proceeding out of the hearing of the jury. Mr. Smith?

13 MR. SMITH: At this time the witness would answer
14 that she advised Mrs. Podendorf that she knew why the police
15 were there. They were there because there had been a killing.
16 That she knew about the apartment. She was there and that the
17 defendant was there. That the woman was suffocated and there
18 was a green footstool found near the victim in the apartment.
19 Mrs. Podendorf didn't believe her, and she showed her some
20 marks on the neck from the victim.

21 MR. REDMAN: I would object at this point in time
22 on the basis of relevancy and hearsay of the conversation.

23 THE COURT: There's no showing the defendant was
24 present. The objection is sustained.

(The following proceedings were
had in normal tones.)

25 (DIRECT EXAMINATION
BY MR. SMITH:)

Q Ms. Taylor, did you happen to show anything to

JoAnn Taylor - Direct

1 Ms. Podendorf when you had your discussion with her at that
2 time?

3 A. I don't believe I showed her anything.

4 Q. Did she make any comment about anything on your body?

5 A. Yes, sir. She stated I had some scratches.

6 MR. REDMAN: I'm going to object on the basis of
7 hearsay --

8 THE COURT: Sustained.

9 MR. REDMAN: -- from whatever was said.

10 THE COURT: Well, nothing was said about whatever
11 was said.

12 Q. (By Mr. Smith) Ms. Taylor, when were you arrested?

13 A. March 15.

14 Q. Of what year?

15 A. 1989.

16 Q. Where?

17 A. North Carolina.

18 Q. Who arrested you?

19 A. The sheriff's department.

20 Q. Did you talk to them that evening?

21 A. Yes, sir.

22 Q. Did you talk to them about the defendant, Joseph White,
23 that evening?

24 A. Yes, sir.

25 Q. Did you talk to them about the Helen Wilson homicide that
evening?

A. Yes, sir.

Q. Ms. Taylor, were you having problems with your memory

1 at that time?

2 A. Somewhat, yes.

3 Q. Do you suffer -- Have you been diagnosed as suffering
4 from some type of a mental condition?

5 A. Yes, sir.

6 Q. And what is that, if you know?

7 A. I have what is known as a personality disorder.

8 Q. Ms. Taylor, the incidents that you have just relayed to
9 the jury regarding Apartment No. 4 and what occurred in that
10 apartment, did the North Carolina police tell you about those
11 incidents?

12 A. No, sir.

13 Q. Did the Gage County Sheriff's Office tell you about those
14 incidents?

15 A. No, sir.

16 Q. Did you dream about those incidents?

17 A. No, sir.

18 Q. Ms. Taylor, how quickly were you returned to the state
19 of Nebraska after your arrest?

20 A. Two days.

21 Q. Were you appointed an attorney then?

22 A. Shortly after, yes, sir.

23 Q. Did you speak with law enforcement -- Do you remember
24 the date that your attorney was appointed?

25 A. No, sir. I don't remember the date.

Q. How -- Can you give me an estimate how long after you
were arrested?

A. Probably -- Approximately about a week.

1 Q. Did you speak with law enforcement officials after
2 that up until the time of your plea?

3 A. I had spoken to them after that, yes, sir.

4 Q. All right. Was your attorney present when you spoke to
5 them?

6 A. Not the first couple of times, no, sir.

7 Q. All right. Was that after your arrest that you spoke to
8 them without an attorney?

9 A. Yes, sir.

10 Q. But after your attorney was appointed, did you speak to
11 them?

12 A. No, sir.

13 Q. And when was the next time that you spoke to law
14 enforcement regarding the homicide?

15 A. When I made my plea agreement.

16 Q. Ms. Taylor, on February 5, 1985, had you taken any drugs?

17 A. Yes, sir.

18 Q. What had you taken?

19 A. I had taken a couple yellow jackets and I had smoked
20 some pot.

21 Q. What is -- What are yellow jackets, if you know?

22 A. They are downers.

23 Q. And what time of the day did you do that?

24 A. Oh, I'd say approximately 3:30, 4 o'clock.

25 Q. In the afternoon?

A. Yes, sir.

Q. Now, did they create for you a high or a low?

A. I was pretty mellow.

1 Q When you entered Helen Wilson's apartment on February 5,
2 did you feel you were under the influence of those drugs?

3 A I was coming down.

4 Q Do you have memory loss from those drugs?

5 A Not from the drugs, no, sir.

6 Q Didn't you once indicate to police officers that the
7 walls appeared to be bleeding?

8 Q Melting, yes, sir.

9 Q Is that the truth?

10 A No, sir.

11 Q Why did you say that?

12 A Trying to cover my rear end.

13 Q When you spoke with the police prior to your plea
14 agreement, had you told them some lies?

15 A Yes, sir.

16 Q Why did you do that?

17 A Covering -- Trying to cover myself.

18 Q Have you told the truth today?

19 A Yes, sir.

20 Q Are you sure?

21 A Yes, sir.

22 Q Ms. Taylor, are you clairvoyant?

23 A No, sir.

24 Q Do you know what that means?

25 A Yes, sir.

~~26 Q Do you know anyone who is?~~

27 A My fiance.

28 Q Ms. Taylor, have any of your recollections of what you've

1 related to the jury come from your fiance?

2 A. No, sir.

3 Q. It's come from whom?

4 A. Myself.

5 MR. SMITH: May I have just a second, Your Honor?
6 Your Honor, at this time the State is done with direct. We'd
7 request that Exhibit No. 37 be allowed to circulate to the
8 jurors.

9 THE COURT: Let's defer that until the examination
10 is done. We can renew your request at that time. Have you
11 finished your direct?

12 MR. SMITH: Yes, Your Honor.

13 THE COURT: All right. Mr. Redman?

14 CROSS-EXAMINATION

15 BY MR. REDMAN:

16 Q. Ms. Taylor, you told us you had some psychiatric
17 problems; is that correct?

18 A. Yes, sir.

19 Q. Why don't we talk about those first. How many
20 psychiatrists or psychologists have you seen or been treated
21 by?

22 A. All together? Approximately five.

23 Q. All right. Could you name some of their names for me,
24 please and when you might have seen them, if you recall?

25 A. I've seen Dr. Price which I saw him in '82 and '83. I've
seen Dr. Logan and Dr. Gutnik which was this year.

Q. Do you remember any other names?

A. I was seen by someone in Rochester Psychiatric Center,

1 but I don't remember the name.

2 Q Dr. Hachiya at one point in time?

3 A I believe so, yes, sir.

4 Q And do you know, Ms. Taylor, how those doctors all
5 diagnosed you?

6 A As having a personality disorder.

7 Q Do you remember if you were ever diagnosed as having
8 a personality disorder with sociopathic features?

9 A Not that I remember, no, sir.

10 Q Is it possible the Dr. Hachiya might have diagnosed you
11 as that?

12 A It's possible, yes.

13 Q All right. And isn't it true, Ms. Taylor, that you, in
14 fact, were under Dr. Price's, a psychologist, care at the
15 time of this murder?

16 A Yes, sir.

17 Q Did any of these doctors that -- Well, are you aware as
18 to whether or not all of these doctors diagnosed you as a
19 person having a borderline personality disorder?

20 A Pretty much, yes, sir.

21 Q Okay. Do you know what they ever said of you that
22 typified that sort of disorder?

23 MR. SMITH: Objection, Your Honor, that's hearsay
24 and speculation.

25 THE COURT: Sustained.

Q (By Mr. Redman) All right. Ms. Taylor, you've talked
about clairvoyance here today. Did you ever recall talking
with any of your doctors about clairvoyance?

1 A. Yes, sir.

2 Q. Why don't you tell me, first of all, tell me what
3 clairvoyance is?

4 A. Seeing into the future.

5 Q. Okay. Did you ever talk about mental telepathy?

6 A. Yes, sir.

7 Q. And can you tell me what mental telepathy is?

8 A. Reading of the thoughts from a distance.

9 Q. Now, you say you don't believe that you're clairvoyant.
10 Do you feel you have mental telepathy capabilities?

11 A. Slightly, yes, sir.

12 Q. And, in fact, what's your boyfriend's name?

13 A. Clint Wanker.

14 Q. Do you remember telling me that you and Clint communicate
15 while you're in jail telepathically?

16 A. Yes, sir, we do.

17 Q. Can you tell me a little bit about that, what you
18 communicate about?

19 MR. SMITH: Objection, Your Honor, relevancy.

20 THE COURT: Sustained.

21 Q. (By Mr. Redman) How long have you and Clint been
22 communicating? Where does he live?

23 A. He lives in Missouri.

24 Q. How long have you been -- Tell me how long have you
25 been communicating telepathically?

A. ~~Since June of '89.~~

Q. Have you seen any visions in your cell since you've
been arrested?

1 MR. SMITH: Objection, Your Honor, relevancy.

2 THE COURT: Overruled.

3 Q (By Mr. Redman) Have you seen any visions in your
4 cell since you've been arrested?

5 A Yes, sir.

6 Q Would you tell us about the visions that you've seen,
7 please.

8 A I've only had one, and it's of a female which is
9 dressed in victorian-style clothing.

10 Q Tell me more specifically has that vision communicated
11 to you, Ms. Taylor?

12 A No, sir.

13 MR. SMITH: Objection, again, Your Honor,
14 relevancy, Your Honor.

15 THE COURT: I think the question is unclear.
16 Sustained.

17 Q (By Mr. Redman) Tell me what the vision is you've
18 described. You've told me what you see, but tell me
19 what it is, if you could.

20 A It's a spirit that's earthbound.

21 Q And can you elaborate more? Can you explain for me?

22 A A person that commits suicide, is earthbound. They
23 cannot enter heaven or hell.

24 Q So this is a spirit that you have seen that committed
25 suicide and therefore, is earthbound that you see in your
26 cell; is that correct?

27 A Yes, sir. I've seen her once.

28 Q And given your telepathic capabilities, have you been

1 able to communicate with that spirit?

2 A. Yes, sir.

3 Q. And how much did you communicate with that spirit,
4 Ms. Taylor?

5 A. I've only seen it and communicated with it once.

6 Q. But this is not the first time you have communicated
7 with spirits, is it?

8 A. No, sir.

9 Q. When else have you communicated with spirits, Ms. Taylor?

10 MR. SMITH: Objection, Your Honor, relevancy.

11 MR. REDMAN: Well, I'm trying to lay the foundation
12 for it, Judge.

13 THE COURT: I'm going to permit the question.
14 Overruled.

15 Q. (By Mr. Redman) When else have you communicated with
16 spirits, Ms. Taylor?

19 A. Five, six years.

23 Q. Do you remember talking to me in a deposition, Ms. Taylor,

1 Q Why don't you relate for the ladies and gentlemen

15 Q. Who helped you with most of the information?

16 A. ~~That's hard to say, because they has been different~~
17 ~~people mention different bits and pieces that's slowly putting~~
18 ~~the puzzle together.~~

19 Q. Who all has helped you with putting this information
20 together?

21 A. Officer Searcey, Sam Stevens has helped and bits and
22 pieces that my attorney has been able to add has helped.

23 Q. Okay. And have these people actually suggested to you
24 that so and so was there or that this happened or that
25 happened to help you?

26 A. Somewhat, but it was -- It wasn't actually put as a
27 suggestion. It was more or less phrased that they -- How
28 was it?

1 Q Well, I guess is what I'm getting at is when they
2 suggested an apartment complex and not a house. That's a

26 Q Do you remember that testimony, Ms. Taylor?

27 A Yes, sir.

28 Q Is that testimony untrue?

1 A. No, sir.

2 Q. So, in fact, Ms. Taylor, the police did suggest to you a
3 number of facts in this case?

4 A. Somewhat, yes.

5 Q. Well, do you disagree that according to your deposition
6 they gave you all of the information?

7 A. They didn't give me all of the information, no, sir.

8 Q. Okay. When did Lobo's name first come up after you were
9 arrested?

10 A. The night I was arrested.

4 A. Yes, sir.

5 Q. Do you remember how they got you to change your mind?

8 building, you could see it. This is a discussion you had with
9 Officer Searcey in your second statement while you were still
10 in North Carolina. Do you remember telling Officer Searcey
11 that the building, that you could see it? It was a light-

13 A. Yes, sir.

14 Q. And do you remember telling Searcey that you could see

21 A. Myself.

22 Q. Nobody else?

23 A. No, sir.

24 Q. Do you remember in your second interview with Officers,
25 Stevens and Searcey saying that you didn't remember being
there?

26 A. Yes, sir.

27 Q. Why did you say that?

1 A. Because I was having trouble with my memory at the time.

2 Q. Do you remember telling Officer Stevens that you weren't
3 sure if Lobo was there --

4 A. I believe so, yes, sir.

5 Q. -- in your second statement?

6 A. I believe so.

7 Q. Do you remember as far back as the 17th of March being
8 shown some sort of photographs of the crime scene by law
9 enforcement or by your attorney?

10 A. I wasn't shown them back in March, no, sir.

11 Q. You say you weren't shown them back in March?

12 A. No, sir.

13 THE COURT: Counsel, approach the bench.

14 (At this point, counsel for the
15 parties approached the bench and
16 off-the-record discussion was
17 had, in low tones, between Court
18 and counsel.)

19 THE COURT: We're going to take a recess at this
20 time, if you'd retire to the jury room, ladies and gentlemen

21 (Whereupon, a recess was taken
22 from 11 to 11:10 a.m.)

23 (At 11:00 a.m. with counsel present and defendant and the
24 jury IN the jury box, the following proceedings were had:)

25 JOANN TAYLOR RESUMED THE WITNESS STAND AND TESTIFIED FURTHER
AS FOLLOWS:

(CROSS EXAMINATION
BY MR. REDMAN:)

Q. We've just come from a recess. Have you talked with
your attorney regarding the facts of this case during the
recess?

A. No, sir.

1 Q. Okay. I think where we left off I asked you whether or
2 not prior to or on the 17th of March you had been shown any
3 pictures of the crime scene or of the case and your answer
4 was "No"; is that correct?

5 A. Yes, sir.

6 Q. Do you remember in your third statement on the 17th of
7 March, Officer Stevens asking you:

8 "Q. Did you ever make a determination as to what that
9 subject's name was at any later time?

10 A. Not until March 17 when I was shown the picture. That
11 helped jog my memory."

12 Q. Do you remember saying that?

13 A. Yes, sir.

14 Q. So you were shown pictures on or before March 16?

15 A. I was shown pictures, but they were not the crime scene.

16 Q. Okay. Do you remember being shown video tapes at some
17 point in time as to a number of pictures of the crime scene to
18 help you jog your memory?

19 A. It was after my plea bargain was made.

20 Q. What date would that have been?

21 A. My plea bargain was made on the 30th of August.

22 Q. And did that help jog your memory?

23 A. I pretty well knew it all before I got showed the
24 pictures.

25 Q. Well, do you remember telling one of the doctors you saw,
~~Dr. Logan, and I think it was on the 1st of September that you~~
admitted at this point that you received copies of the various
witness's statements from your attorney to help your memory?

1 A. Yes, sir, I remember that.

2 Q. And do you remember when you saw the video of the crime
3 scene?

4 A. After my plea agreement.

5 Q. And that date was what?

6 A. The 30th of August.

7 Q. And you saw the entire video; is that correct?

8 A. Yes, sir.

9 Q. And that helped you for your testimony today, is that
10 correct, for your memory?

11 A. Yes, sir.

12 Q. Do you remember that law enforcement, Officer Stevens,
13 asking you whether or not you remembered the victim's body
14 being draped over a piece of furniture?

15 A. Yes, sir.

16 Q. Do you remember if he asked you if you could identify
17 it?

18 A. I believe so.

19 Q. Could you?

20 A. I don't remember.

21 Q. You weren't able to identify it until after he told you
22 what it was, were you?

23 A. I don't believe so.

24 Q. I'm not sure I understand your answer. Is that correct
25 what I said?

26 A. I believe so, yes, sir.

27 MR. SMITH: Objection, Your Honor. I think that is
28 asking a question with facts not in evidence. He said some

1 piece of furniture which he brings back in his question which
2 was a footstool which was not what the previous question
3 was about.

4 THE COURT: Maybe you better restate your question,
5 Mr. Redman.

6 Q (By Mr. Redman) The word footstool originally came from
7 Officer Stevens, didn't it?

8 A I believe so.

9 Q Do you remember telling Officer Stevens that when you
10 left the apartment -- Do you remember telling him who you
11 left with?

12 A Yes, sir.

13 Q It's not the same thing that you testified to today, was
14 it?

15 A I'm not sure.

16 Q Do you remember telling Officer Stevens that you left
17 with Beth and Lobo?

18 A I'm not sure what I said.

19 Q Well, do you remember Officer Stevens' saying:

20 " And you all left together?

21 A Well, Beth and I left and Lobo went his way and told me
22 and Beth that if we were smart, we would stay away from Tom."

23 Q Do you remember that?

24 A I believe so.

25 Q So you and Beth and Lobo left at the same time when you
26 were first interviewed in your third statement by Officer
27 Stevens?

28 A I believe so.

1 Q. And that's not what you've told us today; correct?

2 A. Correct.

3 Q. Now, you talked to us on direct examination quite a
4 bit about the -- or a little bit anyway about the \$5 bill.
5 Do you remember talking about that today?

6 A. Yes, sir.

7 Q. Do you remember when you were first asked about money
8 and how it may have played a role in the murder?

9 A. No, sir, I don't.

10 Q. Well, do you remember when you were interviewed the
11 second time while you were still in North Carolina and you
12 were talking with Officer Stevens from the Gage County Police
13 Department, and there was talk about what somebody had taken
14 out of her purse? Do you remember that?

15 A. Yes, sir.

16 Q. Do you remember what your answer was?

17 A. No, sir, I don't.

18 Q. You said her wallet and you said it was scattered. And
19 Stevens went on:

20 " And what certain item was taken out?

21 A. Her money.

22 Q. What did he do with the money?

23 A. Put it in his pocket.

24 Q. Do you remember that?

25 A. I do now, yes, sir.

Q. You haven't testified to that today, have you?

A. No, sir.

Q. And Stevens asked you if he threw anything on the floor.

1 Do you remember that?

2 A. Yes, sir.

3 Q. Still in the second interview in North Carolina, do you
4 remember what you said?

5 A. No, sir.

6 Q. "He scattered the stuff in her pocketbook." Do you
7 remember that now?

8 A. Vaguely.

9 Q. Do you remember Officer Searcey during that same inter-
10 view asking you if Lobo ever did a trick with money?

11 A. Yes, sir.

12 Q. Did you tell him the same thing you've told us today?

13 A. Pretty much, I believe.

14 Q. Well, let me go over the testimony. Searcey asked this
15 question:

16 " JoAnn, did you ever see Lobo do anything with money that
17 might be a trick or anything that you remember?

18 A. Not right offhand.

19 Q. When you were partying?

20 A. No, because I stayed high worst than the rest of them."

21 Q. Do you remember saying that?

22 A. Yeah.

23 Q. Do you remember Searcey asking:

24 " Did you ever see anybody play games or pull a trick on
25 anybody that might have to do with money?" Do you remember
26 your answer?

27 A. No, sir.

28 Q. You answered:

1 " Lobo played liar's poker a lot.

2 Q Did you ever see him do anything else with money?

3 A He could do hand tricks with it.

4 Q Did you ever see him do anything with destruction of

5 money? What did he do? What did he do?

6 A He would tear it up.

7 Q And why would he do that?

8 A He liked doing it. He thought it was funny, cute.

9 Q What would he do in these particular things?

10 A He would just tear it in a certain way to make different

11 pictures of --

12 Q What would he do with the money after he tore it?

13 A He would wad it up.

14 Q And what would he do with it?

15 A He'd pick it back up.

16 Q Would he throw it away?

17 A All I know is he kept holding it in his hand."

18 Q Do you remember that?

19 A I believe so.

20 Q So would it be correct that when Searcey originally asked

21 you about Lobo's money tricks, you had told him Lobo would

22 make different pictures with the money and finally Searcey had

23 to tell you that Lobo would tear the bill up and throw it

24 away? Do you remember that?

25 A Yes, sir.

~~Q So Searcey is the one telling you about the \$5 bill~~

~~being thrown away?~~

A No, sir.

1 Q. Well, you don't think you're telling -- He didn't
2 reveal anything to you in that testimony?

3 A. He might have, but he's not the one who originally
4 told me about it.

5 Q. Now, about after the murder, he's the one who explained
6 to you about the \$5 bill, was he not?

7 A. Yes, sir.

8 Q. I'm sorry?

9 A. Yes, sir.

10 Q. And that you recalled something entirely different with
11 a \$5 bill, hadn't you?

12 A. Somewhat, yes.

13 Q. Who was Darren Munsterman?

14 A. At the time he was my boyfriend.

15 Q. And you lived with him at that time?

16 A. Yes, sir.

17 Q. Could you describe him for me, please.

18 A. He's about 6'1, got brown hair, about shoulder length,
19 got a full beard and mustache.

20 Q. Looked a lot like Lobo, didn't he?

21 A. No, sir, at the time.

22 Q. Do you remember in your second statement telling the
23 officers that there was a hunting knife involved in this?

24 A. I remember mentioning some kind of knife, but I wasn't
25 sure what it was.

26 Q. ~~There was no hunting knife, was there?~~

27 A. No.

28 Q. In fact, it was a steak knife?

1 A. Yes, sir.

2 Q. Do you remember going into detail how big and ugly that
3 hunting knife was with other officers?

4 A. Yes, sir.

5 Q. Do you remember your second statement with the officers
6 that you told them that no one got hurt in the apartment?

7 A. I couldn't remember anyone getting hurt.

8 Q. Now, you're telling us today that someone was hurt;
9 is that right?

10 A. Yes, sir.

11 Q. In fact, you told them several times that no one was
12 hurt in the apartment, didn't you?

13 A. Yes, sir.

14 Q. Do you remember in your second statement telling law
15 enforcement officers that you never talked with anyone after
16 the incident?

17 A. I believe so.

18 Q. Do you remember telling the officers in your second
19 statement that you thought Joe White was your father?

20 A. Yes, sir.

21 Q. Tell me about that, please, why you thought Joe White
22 was your father?

23 A. Just the way he knew things about me, people I knew.

24 Q. You'd introduce him as your father, wouldn't you?

25 A. Yes, sir.

~~Q. He's only one year older than you. That would be
pretty improbable, wouldn't it? But you still believed that?~~

A. No, sir.

1 Q When did you stop believing that?

2 A In '37 when I met my real father.

3 Q And that's what got you to believe Joe White wasn't
4 your father, wasn't it?

5 A Yes, sir.

6 Q Do you remember being interviewed by Dr. Gutnik on
7 the 30th of May, 1989?

8 A Yes, sir. It was the 28th of April, I believe.

9 Q Let me look. You're memory is pretty good, then,
10 Ms. Taylor, isn't it?

11 A With numbers, sometimes, yes, sir.

12 Q Sometimes it's good and sometime's it's bad, isn't it
13 JoAnn?

MR. SMITH: Objection, it's argumentative.

14 Q (By Mr. Redman) In any event, do you recall talking
15 with Dr. Gutnik?

16 A Yes, sir.

17 Q Do you remember what you told Dr. Gutnik about

10 A. It's possible I could have told him that.

11 Q. Do you remember telling him why you confessed to the
12 police?

13 A. No.

14 Q. Do you remember telling him that he confessed to the
15 police after they told you Joe White told them that you were
16 there?

17 A. Yes, sir, I remember that.

18 Q. Do you remember also telling them that you were
19 convinced by the police Joe White said that you were there?

20 A. I believe so, yes, sir.

21 Q. And you were convinced by the police that Joe White
22 said you were there, weren't you?

23 A. Well, I have a tendency to believe all officers.

24 Q. And so police officers would furnish you information
25 of the crime and you would believe them, wouldn't you?

A. Somewhat, yes, sir.

Q. Do you remember telling Dr. Gutnik that "If Lobo said
it, I'll go along with the bullshit"?

JoAnn Taylor - Cross

1 A. Yes, sir.

2 Q. In fact, you were quite firm with Dr. Gutnik at
3 that point in time that you weren't there, weren't you?

4 A. I believe so.

5 Q. Do you remember telling Dr. Gutnik, in fact, you had
6 been there? You had tried to prevent the crime?

7 A. Yes, sir.

8 Q. Now, you were -- After Dr. Gutnik -- You were
9 interviewed by another psychiatrist by the name of Dr. Logan,
10 weren't you?

11 A. Yes, sir.

12 Q. Do you remember that and that that psychiatrist was
13 for the State, was he not?

14 A. Yes, sir.

15 Q. Now, today you've told us that the victim was dead when
16 you left the apartment or at least appeared to be; is that
17 correct?

18 A. Yes, sir.

19 Q. Do you remember telling Dr. Logan that you thought the
20 victim was still alive when you left the apartment?

21 A. Yes, sir.

22 Q. Were you lying to Dr. Logan?

23 A. No, sir.

24 Q. Why did you tell him that?

25 A. Because at the time it was possible.

Q. I'm sorry?

A. At the time I was not sure of her death.

Q. What made you sure of it?

JOHN TAYLOR - Cross

1 A. Just thinking about it and remembering it.

2 Q. Seeing all the evidence in the case and reading all
3 the witnesses' testimony?

4 A. Not as much as thinking about it, no, sir.

5 Q. But it was pretty firmly in your mind that she wasn't
6 dead for quite some time, was it not?

7 A. I believe so.

8 Q. In fact, it was so firmly entrenched in your mind,
9 isn't that one of the reasons that you didn't want a plea
10 bargain?

11 A. I believe so.

12 Q. All right. You've testified, Ms. Taylor, about having
13 taken a couple of yellow jackets the day of the crime; is
14 that right?

15 A. I smoked some pot and I drank some beer.

16 Q. How did that affect what you saw -- Well, let me put
17 it this way. How did that affect your memory of what
18 occurred on the day of the crime or did it affect your
19 memory?

20 A. I really don't think it did affect my memory.

21 Q. Are you saying that it could have affected your
22 memory?

23 A. It's possible.

24 Q. Are you saying that you may not be remembering correct-
25 ly today?

~~26 A. No. I know I'm remembering pretty correctly.~~

27 Q. And you say you took no more than a couple yellow
28 jackets and smoked some pot; is that right?

21 MR. SMITH: Objection, Your Honor. I think
22 that it is too vague of a question. He said "anything".

23 THE COURT: Sustained and be specific.

24 Q (By Mr. Redman) Did you talk to Deb Shelden in jail?

25 A We talk, yes, sir.

Q In fact, it's not unusual that the two of you talk in
jail, is it?

A No, sir.

Q Have you any conversation with Deb Shelden since this
case has been on trial?

25

JoAnn Taylor - Cross

- 1 A. Some but not about the trial.
- 2 Q. How often do you talk with Deb Sheldon while the two
3 of you are in jail?
- 4 A. Almost daily.
- 5 Q. Are you aware as to whether or not Darren Munsterman
6 had scratches on his neck or anywhere on his body shortly
7 after the murder of Helen Wilson?
- 8 A. Yes, sir.
- 9 Q. He did have scratches, didn't he?
- 10 A. Yes, sir.
- 11 Q. You didn't like Joe White very well prior to the
12 murder, did you?
- 13 A. We were having our disagreements.
- 14 Q. In fact, you had numerous fights, didn't you?
- 15 A. Yes, sir.
- 16 Q. Physical fights, didn't you?
- 17 A. Yes, sir.
- 18 Q. You'd both hit each other, hadn't you?
- 19 A. Yes, sir.
- 20 Q. In fact, on the 5th of February during the day of the
21 murder you and Joe White had a fight down at the R & S bar,
22 didn't you?
- 23 A. I don't remember us fighting at the bar.
- 24 Q. You had a fight on that day in any event?
- 25 A. Yeah.
- Q. Can you tell me what you did on the 5th of February from
the time that you got up that morning. Do you have any idea?
- A. I don't remember right offhand. That's been quite a

1 while.

2 Q Well, that's what the whole trial is about, the 5th --

3 THE COURT: Well, now, counselor, ask proper
4 questions.

5 Q (By Mr. Redman) You have remembered what happened the
6 night of the 5th of February, have you not?

7 A Yes, sir.

8 Q But you don't remember what happened the morning of the
9 5th of February of 1985?

10 A I slept the biggest part of the time.

11 Q We're talking about 1985?

12 A Uh-huh.

13 Q Do you remember what you did when you got up?

14 A Yeah.

15 Q What?

16 A I had done some shopping.

17 Q Where did you go?

18 A Downtown Beatrice.

19 Q What time?

20 A Well, I didn't get up until about 11:30 that day.

21 Q Okay. What store did you go to?

22 A I don't remember, good God.

23 Q Are you -- Now, you testified earlier that the reason you
24 participated in this whole scenario was because of threats
25 made to you and your daughter; is that correct?

26 A Yes, sir.

27 Q How long had it been since you had last seen your
28 daughter prior to the 5th of February?

1 THE COURT: Counsel approach the bench.

2 (At this point, counsel for the
3 parties approached the bench and
4 an off-the-record discussion was
5 had, in low tones, between Court
6 and counsel.)

7 THE COURT: We're going to take our noon recess at
8 this time to 1:30. Again, I want you to observe the admon-
9 ition that you and each of you are admonished by the Court
10 that it is your duty not to converse with or suffer your-
11 selves to be addressed by any person on the subject of this
12 trial, nor to listen to any conversations on the subject.
13 Nor read or listen to any news accounts thereon, and that it
14 is your duty not to form or express an opinion thereon until
15 the case is submitted to you. We are in recess until 1:30.

16 (Whereupon, a recess was taken
17 from 12 to 1:30 p.m.)

18 (At 1 p.m. with counsel for the parties present
19 and the defendant and the jury NOT present, the following
20 proceedings were had in chambers.)

21 THE COURT: Let the record reflect that we are
22 proceeding out of the presence of the jury with both parties
23 present. Mr. Smith, are you the moving party here?

24 MR. STOLER: I would like to make a motion in
25 limine. Defendant comes in limine to preclude the State from
calling as witnesses in the event that the defendant,
Joseph White, testifies, either Dr. Beverly Mead, a psychia-
trist from Omaha or Dr. Henry Balters a psychologist from
Lincoln Nebraska who both examined Joseph White pursuant to
the request of defense counsel. The reason for the motion

1 in limine is it's defendant's understanding that each of
2 these individuals had been subpoenaed by the State to test-
3 ify. We would either ask for the quash of subpoena or at
4 least by moving in limine to preclude them from testifying
5 as made to them or pursuant to psychiatric or psychological
6 tests that were requested and conducted on the behalf of the
7 defendant by request of defense counsel. Furthermore, there
8 was not administering of any type of rights such as Miranda
9 or otherwise explaining that anything that was said during
10 the discussions would be used against Mr. White, and further-
11 more, as each of these doctors were requested by defense
12 counsel, in essence, they are arguments of counsel and acting
13 pursuant to that direction and authorization. Finally, the
14 defendant would submit to the Court that there is a privi-
15 lege under 27-510 or 505 of the Neb. Statutes which allows a
16 privilege to exist between physician and patient and the
17 tests conducted were pursuant to that type of examination
18 that was done by each of these respected doctors and should
19 be privileged if the defendant did not waive the privilege
20 for the information used.

19 MR. SMITH: If it please the Court: Your Honor,
20 the State as far as Dr. Beverly Mead, the psychiatrist is
21 concerned, which would have been an interview taken on
22 September 22, 1989, of the defendant by the doctor, I do not
23 have any knowledge as to whether or not he did or did not
24 read Miranda to him. ~~I'm sorry, I cannot provide that to the~~
25 Court. As far as Dr. Balters is concerned, I would read
from the doctor's report:

1 "The defendant was apprised of the nature of the examination.
2 More, specifically, that all of his answers to this worker's
3 questions as well as his responses to psychological
4 instruments would be utilized as a part of basis for
5 constructing a psychological report. This report in turn
6 would be conveyed to his attorney and used during court
7 proceedings. In other words, there would be none of the
8 confidentiality which would exist between someone such as
9 as a client and this worker.

10 After being so informed the client willingly entered
11 into the assessment situation and was cooperative throughout."

12 MR. STOLER: No further argument, Your Honor, other
13 than what I've already made.

14 THE COURT: Read me that again.

15 MR. SMITH: "The defendant was apprised of the
16 nature of the examination. More, specifically, that all of
17 his answers to this worker's questions as well as his
18 responses to psychological instruments would be utilized as
19 a part of basis for constructing a psychological report. This
20 report, in turn, would be conveyed to his attorney and used
21 during court proceedings. In other words, there would be
22 none of the confidentiality which would exist between someone
23 such as a client and this worker.

24 After being so informed, the client willingly entered
25 into the assessment situation and was cooperative throughout."

26 MR. STOLER: Your Honor, to respond after listening
27 is the argument I made. The exam was done at our request,
28 and there's nothing that that said the information could be

1 disclosed to the prosecution.

2 THE COURT: Aren't you under a reciprocal recovery
3 order?

4 MR. STOLER: As you are aware, we did provide those
5 reports to the Court and the Court felt that the information
6 could be disclosed to the prosecution and through the
7 discovery process that information was turned over, but again,
8 the request was made for the examination by counsel for the
9 purpose of a psychological examination of the defendant, not
10 for any other purpose, Your Honor.

11 THE COURT: Well, I understand what you're saying,
12 but let me stop you. One of the issues does not arise
13 unless the defendant testifies.

14 MR. STOLER: Granted.

15 THE COURT: Secondly, if he does that, whatever the
16 source of the admission, if it is in fact against interest, is
17 appropriate evidence, assuming no privilege is breached. It's
18 the Court's understanding of the cases that if a doctor in
19 making an examination tells the patient that there is no
20 confidentiality involved that that is a waiver of his right
21 to claim the patient-physician privilege. Is there any
22 response you want to make to that, Mr. Stoler?

23 MR. STOLER: The difficulty I have from what was
24 read in the report does not depict that the client understood
25 that it was done, anything more than the request of counsel.

26 As the report indicates, he was told that confidentiality
27 does not exist, but that was told by the doctor. That wasn't
28 represented by the attorney or as far as the request was made

JoAnn Taylor - Cross

1 to begin with.

2 THE COURT: Well, it runs in my mind that there
3 are a number of cases in which the doctor is the one who
4 advised the patient/defendant of that fact and the Courts
5 have held that in that situation the privilege was waived.
6 I'm going to take the motion in limine with respect to
7 Drs. Mead and Balters under advisement with counsel further
8 advising the Court after further investigation if they have
9 any more specific information to give the Court on that
10 point.

11 (At 1:30 p.m. with counsel for the parties present
12 and the defendant present and the jury IN the jury box, the
13 following proceedings were had:)

14 (CROSS EXAMINATION
15 BY MR. REDMAN:)

16 Q Ms. Taylor, this morning you told us that you saw
17 Kathy Gonzalez at 212 North Sixth Street waiving at the time
18 you approached; is that correct?

19 A Yes, sir.

20 Q Now, prior to today, you have made at least four or
21 five statements and you've given a deposition; is that right?

22 A Yes, sir.

23 Q Is it correct that you mentioned that you saw Kathy
24 Gonzalez waiving from that apartment building at any of these
25 times?

A I'm not sure.

Q Well, if you did, can you tell me when you said it?

A I don't know.

1 Q When did you finally decide that you saw Kathy Gonzalez
2 waiving at that apartment building?

3 A I'm not sure what time it was.

4 Q With -- Would it have been within the last week or last
5 month, two months? Can you give me a general idea?

6 A I believe it was mentioned before my deposition, if I'm
7 not mistaken.

8 Q Do you remember who it was mentioned to?

9 A No, sir.

10 Q Do you know whether you mentioned it in the deposition?

11 A I'm not sure.

12 Q If I gave you your deposition, do you think --

13 THE COURT: Now, counselor, you know what's in the
14 deposition. You have it. You can bring it forward.

15 Q (By Mr. Redman) How long has Kathy Gonzalez, if you
16 know, been jail with you?

17 A I'm not sure exactly when she was arrested.

18 Q She's in the same jail as you are, is she not?

19 A Yes, sir.

20 Q Have you talked to Kathy Gonzalez like you talk to Deb
21 Shelden?

22 A No, sir.

23 Q I take it you've never talked to Kathy Gonzalez in jail;
24 is that right?

25 A I spoke to her when my attorney and her attorney was
present the day of my deposition, I believe. You know that.

MR. REDMAN: I don't believe I have any other
questions.

1 THE COURT: Any redirect?

2 MR. SMITH: Yes, Your Honor.

3 REDIRECT EXAMINATION

4 BY MR. SMITH:

5 Q Ms. Taylor, Mr. Redman questioned you regarding some
6 scratches that you've indicated were on a Darren Munsterman
7 at or near February 5 or 6 of '85; is that correct?

8 A Yes, sir.

9 Q And you indicated that you knew he had scratches; is
10 that correct?

11 A Yes, sir.

12 Q How do you know he had scratches?

13 A I placed them there on the night of the 4th of February.

14 Q He also questioned you regarding a possible fight that
15 you were in with the defendant, Joseph White, on February 5;
16 is that correct?

17 A Yes, sir.

18 Q Where did that fight take place?

19 A I believe he's referring to the disagreement that we
20 had when he first made the threat of my daughter and I.

21 Q When was that?

22 A I believe it was early in the afternoon of the 5th.

23 Q Were you ever in a physical fight with Mr. White on
24 February 5?

25 A Not on the day of the 5th except for when he hit me when
26 he was at Mrs. Wilson's apartment.

27 Q Now, he's questioned you about Kathy Gonzalez being in
28 the same jail as you; is that correct?

1 A. Yes, sir.

2 Q. She's not in the same jail cell with you, is she?

3 A. No, sir.

4 Q. Can you talk to her in that jail?

5 A. No, sir.

6 Q. You've indicated you talked to Deb Sheldon while you were
7 in jail; is that right?

8 A. Yes, sir.

9 Q. Did you talk anything about the Helen Wilson homicide
10 with her?

11 A. No, sir. We do not discuss the case.

12 Q. Ms. Taylor, counsel questioned you about the first time
13 you were interviewed by the law enforcement people regarding
14 the place where the homicide occurred, and you indicated you
15 told them. . . What was the place the first time?

16 A. A house.

17 Q. Now, were you interviewed the next day by Gage County law
18 enforcement authorities?

19 A. Yes, sir.

20 Q. Do you remember in your deposition Mr. Redman asking you
21 about sheriff or law enforcement individuals trying to get
22 you to change your mind regarding it being an apartment?

23 A. Yes, sir.

24 Q. And do you remember what you responded to him when he
25 posed that question to you?

26 A. ~~Not right offhand, no, sir, I don't.~~

27 Q. All right. Do you remember this question:

28 " But since the sheriff's office --"

1 MR REDMAN: I'm going to object at this point. I'm
2 not sure if he's trying to impeach his own witness or not --

3 THE COURT: If you want to make a specific
4 objection, I'll hear it, Mr. Redman.

5 Q (By Mr. Smith) "But since the sheriff's office or
6 law enforcement has talked to you, they've got you to change
7 your mind and say this is an apartment building and they
8 told you whether it was nighttime or daytime?"

9 A I didn't change my mind. I remember it as the facts."

10 Q Do you remember that?

11 A Yes, sir.

12 Q Ms. Taylor, do you remember the question that lead
13 up to you identifying the apartment building that's found in
14 in exhibits that you looked at this morning?

15 A No, sir, I don't remember the question right offhand.

16 Q All right. Do you remember was it discussed when you
17 talked with Deputy Searcey and Sergeant Stevens down in
18 North Carolina?

19 A Yes, sir.

20 Q Do you remember Deputy Searcey saying:

21 " Okay. Let's go way back to the beginning and see if
22 we can't remember a little more about the location where this
23 incident might have taken place. Okay --"

24 MR. REDMAN: Could we have a page and what it's
25 being read from?

26 MR. SMITH: 27. It's the statement of the -- The
27 First statement taken down in North Carolina by law enforce-
28 ment officials from Beatrice.

1 MR. REDMAN: Thank you.

2 MR. SMITH: March 16, I believe.

3 Q (By Mr. Smith) The question further went:

4 " Do you recall where this particular residence, where
5 this building may have been located?

6 A. I'm still drawing a blank.

7 Q. Do you recall anything around the area in this particular
8 building that might have helped you out?

9 A. It wasn't far from the school.

10 Q. It wasn't far from the school? In which direction?
11 JoAnn, look at this. Let's say this is the school. Okay.
12 You show me where the --

13 A. That's what I'm trying to do is put myself in the middle.
14 I can see the school. I can see the library.

15 Q. Okay. Is this the library and the school and this would
16 be the alley; is that correct?

17 A. Yes.

18 Q. And somewhere over in this area, somewhere there is --

19 A. The hole in the wall, because the hole in the wall is
20 right off the alley by the school."

21 Q. And then you went on further to say and discussed the
22 matter with him and the Deputy asked you:

23 " Let's see if I can help you out a little bit. Can you
24 recall what this building may have been built out of?" Do
25 you remember your response?

A. No, not right offhand, I don't.

Q. You said, "red brick" and the Deputy:

" Red what?"

1 A. Brick.

2 Q. Red brick. Do you recall was it a single unit or was
3 there --

4 A. It was an apartment."

5 Q. Do you remember that?

6 A. Yes, sir, I remember that conversation.

7 Q. And the Deputy said,

8 " It was a what?

9 A. An apartment building."

10 Q. That's the first time "apartment building" came up in
11 your discussions, wasn't it?

12 A. Yes, sir.

13 Q. The Deputy didn't tell you it was an apartment building,
14 did he?

15 A. No, sir.

16 MR. SMITH: I have no further questions.

17 THE COURT: Recross?

18 RECROSS-EXAMINATION

19 BY MR. REDMAN:

20 Q. Ms. Taylor, regarding the location of the murder, you
21 first told deputies that it was somewhere outside of town,
22 didn't you?

23 A. I told them I wasn't sure.

24 Q. Did you at the same time -- Did you tell them that you
25 weren't sure, that you thought it was somewhere outside of
town?

26 A. It's possible, yes, sir.

27 Q. And you didn't remember the apartment until they

1 indicated to you that it was a building downtown by the
2 school, did you?

3 MR. SMITH: Objection, Your Honor. I don't think
4 that's the evidence that was shown. She brought that up.

5 THE COURT: Sustained.

6 Q. (By Mr. Redman) They obviously, weren't satisfied with
7 your testimony when you told them it was a house.

8 MR. SMITH: Objection, Your Honor, argumentative.

9 THE COURT: Sustained.

10 Q. (By Mr. Redman) They continued to probe, didn't they,
11 when you told them it was a house?

12 A. Yes, but I also informed them that I was quite confused
13 at the time.

14 Q. And they continued to probe, didn't they, when you told
15 them Mark Goodson and Beth Johnson was there?

16 MR. SMITH: Objection, Your Honor. It's outside
17 of recross.

18 THE COURT: Sustained.

19 Q. (By Mr. Redman) Now, Mr. Smith asked you about the
20 deposition and you indicated or I guess he -- I can't
21 remember if he read it or you said it, but the police didn't
22 get you to change your mind in the deposition. But there
23 were also places in the deposition that you told me that
24 everything that the police told you helped you remember,
25 were they not?

A. Bits and pieces, yes, sir.

MR. REDMAN: I have no other questions.

THE COURT: Any redirect?
